PURSE DISTRIBUTION:

60% to winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. 10% of nomination and sustaining payments from each division to be deducted prior to purse distribution for Consignor Awards and/or Berth Awards. 10% of nomination and sustaining payments from each division to be deducted and retained by the Texas Thoroughbred Association for administration of the Futurity.

CONSIGNOR AND BERTH AWARDS DISTRIBUTION:

10% of the nomination and sustaining payments from each division is allocated to Consignor Awards and/or Berth Awards. This 10% is to be paid out in the same allocations (60%/20%/10%/5%/3%/2%) as the purse.

If a horse finishing first through sixth in the finals of either division of the 2011 TTA Sales Futurity passed through the ring at the 2010 Fasig-Tipton Texas Summer Yearling Sale, either the 2009 or 2010 Fasig-Tipton Texas Mixed Sales, or the 2011 Fasig-Tipton Texas Two-Year-Olds In Training Sale at Lone Star Park, the consignor award is paid to the seller (owner of said horse at time of the sale) of that horse. If a horse finishing first through sixth in the finals of either division of the 2011 TTA Sales Futurity passed through the ring at two (or more) of the sales, the consignor award will be divided equally between the consignors of the horse in each of the sales.

If a horse finishing first through sixth in either division of the finals of the 2011 TTA Sales Futurity became eligible to the race through nomination as a "Consignor Berth", the Consignor/Berth Award will be paid to the appropriate consignor who sold a yearling in the 2010 Fasig-Tipton Texas Summer Yearling Sale or the 2010 Fasig-Tipton Texas Mixed Sale and was the original rights holder to that consignor berth.

If a horse finishing first through sixth in either division of the finals of the 2011 TTA Sales Futurity became eligible to the race through nomination as a "Buyer Berth", the Consignor/ Berth Award will be paid to the appropriate buyer who purchased a yearling in the 2010 Fasig-Tipton Texas Summer Yearling Sale or the 2010 Fasig-Tipton Texas Mixed Sale and was the original rights holder to that buyer berth.

DETERMINATION OF FINALISTS:

Maximum of 12 finalists in each division will be determined by order of finish in Trials. If necessary, there will be a "shake" to determine last finalist(s). In case of a dead heat in a trial race, the horse losing the "shake" may be entered in the final but will only run if one or more trial qualifiers do not enter. No consolation race will be run. There will be an "also eligible" list only if an also eligible list is policy of Lone Star Park at the time of the trials.

RACE FORMAT:

All foals of 2009 that pass through the ring in the 2010 Fasig-Tipton Texas Summer Yearling Sale or either the 2009 or 2010 Fasig-Tipton Texas Mixed Sales, or are consigned to and subsequently pass through the ring at the 2011 Fasig-Tipton Texas Two-Year-Olds In Training Sale at Lone Star Park will become eligible for nomination and sustenance to the appropriate division of the 2011 TTA Sales Futurity.

For every foal of 2009 that passed through the ring at the 2010 Fasig-Tipton Texas Summer Yearling Sale or the 2010 Fasig-Tipton Texas Mixed Sale, each consignor or buyer will receive a transferable berth into either division of the race. Any Thoroughbred foal of 2009 is eligible to be sold in the sales and nominated to the Futurity. Additional berths must be filled with an "Accredited Texas-Bred Thoroughbred" foal of 2009 that **did not** pass through the ring at the 2009 or 2010 Fasig-Tipton Texas Mixed Sale or the 2010 Fasig-Tipton Texas Summer Yearling Sale by the December 31, 2010 nomination deadline. Once a designated horse is nominated to fill a berth, ownership of that horse may be transferred with the horse still remaining eligible for the TTA Sales Futurity. Total payments to start in trials of the 2011 TTA Sales Futurity will be no less than \$1,500 per horse.

Horses filling consignor berths and buyer berths must be designated at the time the December 31, 2010 nomination payment is made. Berths must be filled with an Accredited Texas-Bred foal of 2009. There are no provisions covering substitution of a designated horse.

Please note that prior to nomination, berths are transferable. A \$100 berth transfer fee will be payable to the TTA on all berths changing hands prior to the December 31, 2010 nomination deadline. Consignor berths are for the owner of the selling yearling at the time of the sale. Buyer berths are for the purchaser of the selling horse whose name the horse is transferred to at the time of sale. A photostat copy of the front and back of The Jockey Club registration papers must accompany nomination payment, or eligibility of that horse in the 2011 TTA Sales Futurity may be refused.

GOVERNING ORGANIZATIONS:

Any nomination accepted on a foal subsequently found not to be eligible may be cancelled with no liability to TTA or host track except the return of fees paid.

If a mechanical failure of the starting gate occurs, or if a horse is inadvertently left behind the gate when the field is dispatched during a trial, such horse shall be declared a non-starter and all nomination, entry and starting fees shall be refunded.

A sufficient number of trial races will be carded and run on the advertised date(s). The number of trial races run will be dictated by the number of entrants. In the event that 12 or less horses pass the entry box for trials, the trial races will be cancelled and the finals will be run on the advertised date.

RACING COMMISSION RULES:

The owner or his agent signing nomination attests that he, and all persons for whom he is acting, have read and are familiar with the Rules of Racing and the regulations of the Texas Racing Commission and Lone Star Park at Grand Prairie race meeting conditions and agree to be bound by and comply with same, and with the acts and decisions of the Texas Racing Commission, Lone Star Park racing officials and the following terms and conditions:

Stable reservations and entries in stakes and all other races are received and accepted subject to rules of Lone Star Park at Grand Prairie. Failure by an owner and/or his agent to comply with stall allocations or entry eligibility rules, set forth by Lone Star Park at Grand Prairie, shall not constitute reason for return of nomination and sustaining payments. Said payments will remain in the purse.

Nominations or subscriptions to this Futurity may be refused or cancelled, without liability, at any time prior to the actual running thereof, except for the return of any nomination and sustaining fees paid.

The TTA reserves the right to cancel, postpone, or change the conditions of all or any part of the race for any reason which it deems good and sufficient.

Participants are required to be TTA members from time of nomination until the race is run.

If a horse is leased, both lessor and lessee must be members in good standing of TTA. In a partnership or syndicate, one of the partners or the syndicate manager must be a member in good standing with the TTA. (A member in good standing being one who has paid current membership dues and has no delinquent account with TTA. TTA offers varied membership packages. Please call 512-458-6133 for more information.) In the event that a nomination fee or sustaining payment or entry fee is made with an insufficient funds check, the horse is automatically ineligible.

Closing dates to nominate are final. If entries and sustaining payments are mailed, they must be postmarked no later than midnight of the date due.
